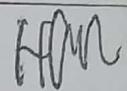
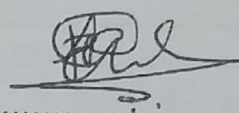

1. The name of the Company is **ZUNGO TOURS LIMITED**
2. The Registered Office of the Company will be situated in Paje, Zanzibar.
3. The objects for which the Company is established are:
 - a. To carry on the business of tour and travel agents and to facilitate travelling and provide for tourist and travellers such facilities and assistance and attractions in the way of cars, berths and aircrafts.
 - b. To assisting tourist and traveller in obtaining reserved places, hotels and restaurants, lodging, accommodation, tour guide, safe deposits, enquiry bureau, baggage transport and otherwise to arrange, organize and arrange tours for sight-seeing, walking and cycling tours of town, sports, boating, dhow safaris, fishing, goggling, water sports, guided on non- guided tours in any part of the world.

To purchase, take on lease or otherwise acquire buildings and properties in Zanzibar or elsewhere and to convert the same into restaurants or hotels and to carry on the business of restaurateurs, caterers, cafes, boarding and lodging housekeepers, licenses victual's, wine and spirit merchants and tobacconists.

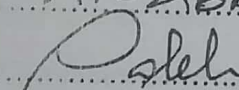
