1.0 The name of the Company is **EMLESS TOUR AND TRAVELING (SMC-PRIVATE) LIMITED.**

2.0 The Registered office of the company will be situated in Zanzibar.

3.0 The objects for which the company is established are:-

- 3.1 To carry on the business of tour operators, agents of tour operators, travel agents, and owners of motors vehicles, motor –car hirers and fishing, sports, diver, ticketing, and other kind of description.
- 3.2 To carry on the business of safari and tour operators organizers and outfitters and to promote arrange organize conduct and facilitate tourism and travel by land sea and air in and to Tanzania and elsewhere and to carry on the businesses of travel and tourist agents in all their branches.
- 3.3 To carry on the business of Hotels, tour operators, agents of tour operators, lodges, motels, resorts, club, renting house, cafes, cars, tours operation, casinos, hirers of conference hall and generally to manage restaurants, beach, bungalow and also to provide secretarial services to guests and members of the public.
- 3.4 To carry on the business of air, sea land transporters of goods and passengers, in particular to engage in the business of tour and travel agents, facilitate travelling, to provide for tourists and travelers such facilities, assistance and attractions in the way of cars, berths, reserved places, hotel, lodging accommodations, guides, safe deposits, inquiry bureau and otherwise to arrange, organize and operate tours for sight-seeing, walking cycling tours of towns, and also to arrange and organize boating, dhow safaris, goggling, fishing and water in Zanzibar and elsewhere.
- 3.5 To carry on the business of Diving, cruising and fishing, giving diving and swimming courses, charter of boats, line fishing game, fishing deep-sea sports, goggling, scuba diving, snorkeling, sailing, wing surfing and water

duly audited and reports as are referred to in those sections. They shall in all respects comply with the provisions of section 154 to 160.

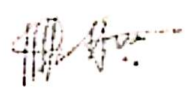
32. So long as the company has only one director, the requirements of section 241 shall be deemed to have met if the balance sheet and profit and loss account is authenticated by the sole director.

33. Auditors shall be appointed and their duties regulated in accordance with the provisions of sections 166 to 169.
