

DEED OF PARTNERSHIP

THIS DEED OF PARTNERSHIP made the 29th day of September, 2019. BETWEEN **TWAHIR AMOUR RAMADHAN** of Uroa-Zanzibari holder of Zanzibar ID No. 580023422, hereinafter called the **FIRST PARTY** (which expression shall include his heirs, successors, administrator and assigns) of the first part AND **ABDILLAH AMOUR RAMADHAN** of Uroa-Zanzibar holder Tanzania ID No. 19991118-72207-0001-22 hereinafter called the **'SECOND PARTY'** (which expression shall include her heirs, successors, administrator and assigns) of the Second Party.

AND WITNESSES that each of the said parties hereby covenant with the others of them jointly and severally in manner following, that is to say:

1. The Partnership shall be doing a tour business under a firm going by the name of **Maracuya Tours & Safari's Partners**.
2. The **PARTNERSHIP** shall cease if the parties decide to incorporate a company to take over from the firm. The partnership may also come to an end on mutual agreement of the parties and in that case the property of the Partnership shall be disposed and the proceeds divided according to the percentage of contribution of each part.
3. The Partnership shall not cease or come to an end in the event of death or bankruptcy of any of the part instead the heirs, legal representatives may take the place of the deceased part or may sell his/her shares to the remaining parties. In case of bankruptcy or insolvent of one of the parts, the liquidator or such other person shall sell to the remaining part's the shares previously held by the bankrupt party at a value to be determined by official valuer recognized by law.
4. The registered office of the Partnership will be in Uroa- Zanzibar and other place as the partners decided.
5. The capital of the Partnership shall be the sum of TSh 63,400,000/=) only, to be contributed as follows: -

- First Party contribution TSh. 31,700,000/=50%
- Second Party contribution TSh. 31,700,000/=50%

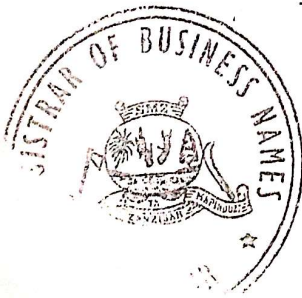
